#### About the Workshop

The WTO has recently commemorated its 25th anniversary. In the course of its short history, the WTO has managed to achieve and establish its objectives more than any other International Organization in the world. From establishing interconnectedness between the world countries to developing jurisprudence, the organization played a key role in the development of multilateral relations. India has been one of the most active participants in the WTO's mechanism and also one of the major contributors to its International trade jurisprudence. On the other hand, India's interconnectedness in the global order through the course of history has been to a large extent shaped by its International Trade and Commerce. It is never an understatement to say that trade acts as a catalyst for the establishment of strategic alliances. Despite the fact that International trade has seen an unprecedented rise in the past years, changed the perception of globalization, protectionist policies, disruptions in the administrative functions of the WTO, lack of precision in the WTO agreements and, several other factors have disrupted International Trade. Now as we move into the third decade of the century, the world is facing a new face of challenges amid the pandemic. The COVID-19 has not only shocked the global economy but set several challenges and impediments to the International Trade order. Several International Economic Organizations predict shrink and downfall in the global economy. India's share of challenges also comes with its share of opportunities. It is important to explore these challenges and opportunities in order to ascertain India's policy priorities and also, its vision for the world. Therefore, to explore the tenets of India's trade policy in the post-pandemic world and, to encourage dialogue, debate, and discourse on International Trade, the Indian Forum for Public Diplomacy (IFPD) along with Global Policy Insights (GPI) initiates a workshop on "International Trade and WTO @ 25 - Assessing Geopolitics, Economy and Trade Policy of India in the post COVID- 19 World."

#### Overview of the Course

- The Workshop shall be a 6-day event composed of a series of 10-12 lectures, discussions, discourses
  delivered by experts from the field.
- We also encourage debates between student groups during the course of the workshop.
- Each day shall consist a maximum of 2 sessions in the evenings (Morning and evening on Sunday) on various topics concerning International Trade, Trade Law, Economy, and Trade Relations.
- It is mandatory for the participants to fill a feedback form after each session and the minimum requirement of attendance shall be 70%.
- Upon the completion of the workshop, it is mandatory that each candidate shall submit an article or research paper (1200-2000 words) in the areas concerning International Trade and Relations.
- All submissions shall be published on IFPD's special edition on International Trade and Economy.
- Few selected authors shall be called upon again to undertake research under the guidance of our junior fellows and Board of Advisors and convert their papers into policy proposals which shall be sent to the Ministry of External Affairs/ DGFT or Ministry of Commerce as policy recommendations.
- All the participants shall be provided with a certificate of participation post their submissions for their participation and contribution to the workshop.

#### Objectives of the Course

- To provide young academia an opportunity to explore the contours of International Trade, Policy, and WTO Studies.
- To lively interact with experts from the field and to pool knowledge, experience and expertise of various
  academia in International Trade and Relations.
- To help young participants explore the prospects of International Trade.

- To acquire insights from both experts and young students for ascertaining India's policy decisions in order to make recommendations in trade reforms and practice.
- To encourage dialogue, debate, discourse, and research among the policy community and young academicians.

#### Learning Outcomes

- Participants will be able to learn some of the critical issues in International Trade, Relations, and the
  implications of changing world trade and economic dynamics on India.
- Participants will be able to develop or suggest pro-active solutions for some of the key issues in International Trade and Relations through active dialogue and debate.
- Participants will be able to contribute research on the subjects and areas discussed in the course.
- Participants will be able to explore the contours of International Trade and WTO studies which shall help them understand the career prospects in International Trade and Relations.

Prof. Dr. Abbijit Das is the Head & Professor at Centre for WTO Studies, Indian Institute of Foreign Trade (IIFT). He combines extensive experience and expertise in International Trade Negotiations with formulating, implementing and managing trade-related capacity-building projects. He worked at the United Nations Conference on Trade and Development (UNCTAD), India programme before he joined IIFT between 2005-10. Mr. Das has also worked as a Director at Trade Policy Division in the Ministry of Commerce, Government of India between 2000-05 and made substantial contributions in developing India's negotiating position on several trade issues including Anti-dumping, Subsidies under the Doha Round at the WTO and OECD Steel subsidy negotiations. He also contributed and co-ordinated in India's submissions in various landmark WTO disputes. Mr. Das was an officer of the Indian Audit and Accounts Service (1988) batch and an officer of premier civil service for more than 21 years.

Ms. Shailaja Singh is a Legal Consultant at the Centre for WTO Studies, Indian Institute of Foreign Trade (IIFT), New Delhi, She is a lawyer and trade policy advisor with over a decade of experience in international economic law; and is part of the Government of India's trade negoriation, policy and dispute teams. She has previously worked as an associate at AZ&B Partmers, Mumbai and in International Private Banking at ICICI, She has also worked at the Advisory Centre on WTO Law (ACWL), Geneva, Switzerland. Mrs Shailaja has acted as a Legal Counsel to the Government of India in several WTO disputes and has participated in the dispute proceedings at the WTO. She advises the Government of India (the Ministry of Commerce and Industry in particular) on issues pertaining to the WTO and free trade agreement rules and negotiations. Mrs Shailaja is also part of the Centre's core team for training programmes on international trade issues conducted under the India Technical and Economic Cooperation (ITEC) initiative of the Ministry of External Affairs. In this role, she has trained about 1000 foreign officials from over 50 countries to date.

Ambassador Anil Trigunayar is a former Indian Foreign Service (IFS) officer and has served as Ambassador of India to Jordan, Libya, and Malta. Mr. Anil is currently the president of MIICCIA Chamber of Commerce, Secretary to the Association of Indian Diplomats, Distinguished Fellow at the Vivekananda International Foundation, and the Member of Governing Council of the Raisina House. He is also an advisor at the Asia Africa Chamber of Commerce and BRICS Chamber of Commerce. He is a Post Graduate in Physics from the Agra/Kumaon University, and also studied Russian History, Culture, and Language at the Jawaharlal Nehru University, New Delhi. As a visiting fellow, he also conducted research work on "WTO and Regional Trading Blocs" at Oxford University. In the Ministry of External Affairs, he has worked in the Economic, West Asia, and North Africa and Consular Divisions. He also served as Director-General/Joint Secretary for the Gulf & Haj Divisions in the Ministry of External Affairs, New Delhi.

Mr. Manab Majumdar is the Deputy Secretary-General of Federation of Indian Chambers of Commerce Industry (FICCI), the premier apex business chamber of India. With 30 years of experience in research and advocacy in WrO studies, Free Trade Agreements (FTA), Trade Policy, Globalisation, Investment, and industry-related issues, he currently also leads the Trade Division at FICCI. Mr Manab has been closely involved in the negotiation and industry consultation process for a number of FTAs involving India and participated in several WrO ministerial conferences as a member of the official Indian delegation. He also represented the Indian private sector in a large number of international conferences and high-level policy dialogues in Trade and WrO related issues. Mr Manab is an alumnus of Presidency College Calcutta, Jawaharlal Nehru University (JNU), New Delhi, and has extensively worked before on India's trade and investment relations with South-East and North-East Asian countries.

Ambassador Vishnu Prakash is a retired Indian Foreign Servant and presently he serves as a foreign affairs analyst at multiple think tanks and organizations. He was an Ex-Envoy and has served as High Commissioner to Ortawa, Ambassador to Seoul, Official Spokesperson of Foreign Office, and Consul General to Shanghai. He has also done postings in Moscow, New York, Vladivostok, Tokyo, Islamabad, and Cairo. Since retirement in Nov. 2016, he has turned into a foreign affairs analyst & commentator, with a special focus on the Indo-Pacific region

Dr. Parth I Shah an economist, public policy specialist and is the founder of the Centre for Civil Society (CCS) and the Co-Founder, Director Director of Indian School of Public Policy (ISPP). Mr Parth's research and advocacy focus on the themes of economic freedom, choice and competition in education, property rights, trade and environment. Through his marker-liberal think tank, CCS, he promotes social change through Public Policy. He is a member of the education task force of the governments of Delhi and Karnataka and serves on the Senate of the Central University of Himachal Pradesh and Tamil Nadu. He holds a PhD in economics and has taught at the University of Michigan and been a visiting faculty at JNU, Delhi and MS University, Vadodara. As the President at the Centre for Civil Society, he has steered the Centre's Hagship School Choice Campaign, including India's first school voucher pilot reaching out to 400 students and the National Independent Schools Alliance - an alliance of 55,000 budget private schools across 20 states in India.

Mr. Sanjay Norani is a partner at ELP Law and Co-Heads, the International Trade and Customs Practice. He is a member of the Supreme Court Bar of India (SCBA), The American Bar Association (ABA), and has the distinction of being appointed to the ABA's steering group of Export Controls & Economic Sanctions representing Asia. Mr. Sanjay has contributed to the cases before WTO representing India and he is also a member of the Indo-Pacific Bar Association (IPBA) and Customs and International Trade Bar Association (ICITBA) and represents various committees. His advisory work includes appellate litigation to obtain trade remedial reliefs from unfair trade imports in anti-dumping. Trade Remedial Actions, and Disputes on Free Trade Agreements (FTA's). He provides advice for various negotiations undertaken by India on Free Trade and Regional Trade Agreements and also advises businesses on Non-Tariff Barriers. With over 2 decades of expertise in WTO and Trade Law, Sanjay has also implemented and led the research project that monitors SPS Measures of trade that is likely to be incompatible with the provisions of WTO.

Dr. Probal Ghosh, is a former Indian Naval Servant and a SEAS Fellow with the outstanding prerogative of being both the Lead Co-Chairman and India Representative to two consecutive CSCAP International Study Groups on Maritime Security (Council for Security Cooperation in Asia Pacific Region is the Track II version of the ASEAN Regional Forum to whom it reports) during which he along with delegates from nearly 22 countries prepared two Memorandums forwarded to ARF Summit meets.
